

Call for Expression of Interest (EoI) – Consultancy Services for Training on Industry Self-Regulation (ISR)

#### 1) Background:

Kilimo Trust is a not-for-profit organization working on agriculture for development across the East Africa community – in Burundi, Kenya, Rwanda, Tanzania and Uganda. Kilimo Trust is a go-to implementing partner for inclusive and sustainable market-led agricultural value chain development in the region.

Kilimo Trust received a grant from AGRA to implement a three-year project entitled "Enhancing Access to Markets for Inclusive Agricultural Transformation (EAMIAT)." The project aims to improve the income, food, and nutrition security of MSMEs and farmers by creating sustainable trade opportunities. Implemented by a consortium of four partners, Kilimo Trust focuses on promoting innovative post-harvest handling (PHH) practices to ensure grain quality in the Busoga, Sebei, and Bugisu subregions of Eastern Uganda.

Industry Self-Regulation (ISR) is a crucial mechanism for ensuring compliance with ethical, safety, and quality standards within various industries. By adopting ISR standards, Kilimo Trust will proactively manage risks, enhance consumer trust, and align with best practices without relying solely on external regulatory bodies. For this project, ISR is particularly relevant as it provides a structured approach to maintaining industry integrity, fostering innovation, and ensuring long-term sustainability. Training on ISR standards will help stakeholders understand their roles in upholding these standards, leading to improved grain trade and adherence to quality requirements

### 2) Scope of Work:

The trainer will conduct three (3) region training sessions on ISR standards, each hosted in a different location

- Busoga Region Training will be held in Iganga town.
- Bugisu Region Training will take place in Mbale town.
- Sebei Region Training will be conducted in Kapchorwa town.

A total of 300 participants will be trained, with 100 participants per region.

### Objectives of the Training Sessions:

- a) Provide participants with a clear understanding of ISR standards and their practical applications. Promote compliance and best practices by equipping attendees with strategies to effectively implement ISR standards, ensuring regulatory adherence and quality improvement. Identify common obstacles to ISR compliance and provide actionable solutions to overcome them.
- 3) The Consultant tasks will include the following:

The trainer will undertake the following tasks to deliver the objectives:

- a) Develop training materials tailored to the needs of participants
- b) Conduct Three (3) training sessions, one in each designated region
- c) Provide post training support, including Q & A sessions and additional resources
- d) Submit a report detailing the outcomes of the training and participant feedback

- d) Demonstrated experience working with smallholder farmers and local communities.
- e) Proven track record in developing and adapting training materials tailored to diverse audiences
